### From the CEO: A Fast February

The 87th Texas Legislative Session began just a few weeks ago. The TETAF Advocacy team is focused on our legislative priorities, and holding meetings with stakeholders and legislators. We are also closely monitoring bills as they are filed. TETAF is surveying the Regional Advisory Councils (RACs) once again to gather input on the latest details in their response to the COVID-19 pandemic and other needs. Additionally, in past years TETAF has hosted a Day at the Capitol, but due to COVID-19 we are planning a more personalized strategy in place of holding this event.

It is good to see our staff and surveyors busy traveling to hospitals for surveys. Our team continues to work with hospital partners and surveyors to ensure our COVID-19 Safety Plan is implemented. We are also working with our hospital partners in areas where there is still a higher response to COVID-19 cases.

February is also a busier month for events, especially for Texas Perinatal Services. We are proud to once again be a sponsor of the Texas Collaborative for Healthy Mothers and Babies (TCHMB) Summit, which will be virtual this year. Additionally, Texas Perinatal Services has partnered with the Institute for Perinatal Quality Improvement to bring the SPEAK UP Champions© Implicit and Explicit Bias LIVE Virtual Conference. The focus of this conference is providing quality equitable care and reducing health disparities.

Our first quarterly meeting of the TETAF Board of Directors in 2021 will be February 16. TETAF will continue to host our meetings via Zoom for now. We will follow our same scheduling pattern by holding board meetings the same week as the Governor's EMS and Trauma Advisory Council (GETAC) meeting, which is February 19. Also that week, the Texas Trauma Quality Improvement Program (TQIP) will host its first meeting of the year, also on February 16.

We are thankful to once again have a busier calendar and look forward to everything we can accomplish for trauma, stroke, maternal, and neonatal care during this time.

## 87th Legislative Session

The 87th Texas Legislature gavelled in on January 12. This session is off to an unusual start due to COVID-19 and legislators not convening as frequently on the House and Senate floors. On opening day, the House elected Representative Dade Phelan (R-Beaumont) as Speaker.

The Senate was first to release its committee assignments and committees have started meeting. Among the Senate committee meetings we will closely monitor are the [Finance Committee](#) and the [Health and Human Services Committee](#).

Last week, the House announced its committee appointments and among those TETAF is closely following are the [Appropriations Committee](#), [Public Health](#), and [State Affairs](#).

Our Legislative Workgroup calls have been well-attended the past few weeks. In addition to discussing what is happening during the legislative session, [TETAF's Legislative Priorities](#) have also been discussed. 


## 2021 Texas EMS Conference in Austin
