RAC-G: Public Education & Injury Prevention Committee

Wednesday, July 17, 2024

Call to order

A meeting of RAC-G Public Education & Injury Prevention Committee was held via Teams link on 7/17/2024

Approval of Previous Meeting Minutes

Minutes from previous meeting approved as presented.

Purpose of Meeting: Provide collaboration opportunity for entities impacting public education and injury prevention as well as those who provide care of injured patients within RAC-G.

1. Topic of Discussion

The committee reviewed team survey related to PEIP Sections of RAC Self-Assessment and created SMART Goals related to items scored lower than 3. The goals determined by the committee are below:

Item 17 - rated and average of 2

Goal: The RAC PEIP Committee will implement an evidence based injury prevention course including at least one community partner at each course/event monitored through RAC committee meetings for at least 2 of our top five mechanisms of injury based on regional trauma registry data by June 2025.

Item 18 - rated an average of 2

Goal: The RAC will sponsor and/or support regional education events geared towards patient care and outcome improvement. The event coordinator will provide evaluation details to RAC leadership utilizing a RAC provided feedback form to allow for annual reporting and evaluation by the RAC for future support within 90 days event completion.

The committee reviewed the FAC Fall Prevention Course - 9/21 confirmed as date. City of Tyler Library confirmed as location and does not charge for these events. Committee members to begin working on locating vendors for event that will provide fall prevention resources to community members. Brittany has a presentation that can be used for the training course portion. Further discussion planned for August meeting.

2. New Business

Julie Sperling has been nominated and voted unanimously by those in attendance as the choice for PEIP committee co-chair. Recommendation will be made to RAC staff for presentation and approval of the board.

3. Old Business

PEIP funding requests were agreed upon by the committee and will be submitted to the RAC staff by Monday 7/22. RAC staff in attendance were unable to provide an amount for requests to stay within and asked that we provide 2-3 quotes for each product requested for review by the finance committee. The RAC staff did note that previously offered funding for this committee this year has been spent on other requests. PEIP funding requests will be pushed to next fiscal year.
