A recap meeting of the Perinatal & Women's Health Committee was held Via Teams on February 4, 2025.

Purpose of the Meeting:

- Follow up on RAC-G General Assembly and RAC-G Perinatal & Women's Health Committee meeting discussing new items of business, updates on the perinatal bracelet project, discussion of process improvement for the project's success, and discussion about follow-up with patients for project efficacy.

1. Items of Business:

- Process improvement initiative within RAC-G as required for DSHS suggests a multidisciplinary committee. They will need hospital leaders, nurses, and MDs to participate. Please notify a committee leader if there is any desire for participation.
- Pulsara-Texas requires purchase of this program. It is provided to EMS for free. The basic package is provided with hospital potential to upscale. If there are any needs for training let a RAC committee member know. Josh Jordan is the Pulsara Representative. The website for education is: Pulsara.com/Texas-resources.
- Collaboration potential with the Trauma committee for a trauma symposium on July 31, 2025 & August 1, 2025. Any there is anyone interested in speaking on behalf of OB please notify a perinatal committee representative.

2. Recap the Perinatal Bracelet Project:

- UT Athens- Roll out is going well. Several patients have returned through the ER wearing the bracelet. Bracelet and education provided to patients at time of discharge.
- UT Henderson-Roll out planned to be initiated during the month of February.
- UT Jacksonville- Project hasn't been rolled out entirely to this point. Will work on official roll out prior to the next RAC-G Perinatal & Women's Health Committee meeting.
- UT Tyler- Roll out is going well. Education is being provided and bracelets are being placed on patients during the admission process along with all other admission bands. Education has been posted in triage areas, labor rooms, and ED. ED staff has also been educated. Would like to receive more follow-up information. Not getting much feedback regarding patient's wearing the bracelets on return.
- Christus Longview-Roll out going well. Bracelets and education being provided to patients at time of discharge. The facility has created tear pads of the flyer. The clinics have been provided with extra bracelets to hand out as needed to patients who return in the clinic without a bracelet.
- Christus Tyler- Will work on official roll out prior to next RAC-G Perinatal & Women's Health Committee meeting.
- LRMC- Will work on official roll out prior to next RAC-G Perinatal & Women's Health Committee meeting.

- Palestine RMC- Roll out is going well. Moms have been very receptive. Will follow up with ED regarding success with patients returning to the ED wearing the bracelets.

Action: Goal set for all pending roll outs to be initiated prior to the next RAC-G Perinatal & Women's Health Committee meeting in April.

3. Review of the follow-up questionnaire form for Perinatal Bracelet Project:

- Discussed the follow-up form and approved the questions currently on the form.
- Decision to incorporate a QR code to replace the paper form for an attempt at improvement on patient completion and data collection. ****QR Code created and form viewed and discussed for distribution.**
- Additions to be made include adding the delivery facility and delivery provider to the form along with additions of the RAC-G logo and a picture of the bracelet.
- Create a Teams database or explore other database options for reporting the results amongst the RAC-G Perinatal & Women's Health Committee.


4. Open Discussion:
