Perinatal Advisory Council

The Perinatal Advisory Council (PAC) held its meeting virtually on March 31. During the meeting, Dr. David Weisoly, a member of the TETAF Board of Directors, presented on the [Newborn Admission Temperature project](#). It is a quality improvement (QI) initiative hosted by the Texas Collaborative for Healthy Mothers and Babies (TCHMB) in a partnership with the Regional Advisory Council (RAC) Perinatal Committees to increase the proportion of newborn infants with admission temperatures within normal limits through the implementation of best practices.

229 neonatal facilities have been designated in the first cycle. Of these:

22 are Level IV,

60 are Level III,

63 are Level II, and

84 are Level I.

This is an adjustment from the previous PAC meeting. Three facilities closed OB services.

For maternal:

101 facilities have been awarded designation. 24 are Level IV, 26 are Level III, 37 are Level II, and 14 are designated as a Level I. August 31, 2021 remains the deadline per statute and there is not a legislative extension at this time.

87th Legislative Session

The TETAF Advocacy team is actively monitoring bills related to maternal care, along with attending committee meetings and meeting with legislators. Among the many bills TETAF and Texas Perinatal Services are following is Senate Bill (SB) 1, which focuses on the state's budget. As filed, the bill appropriates \$10.2 million more for

women's health, including the continuation of the Healthy Texas Women program's enhanced postpartum care services. It also allows for \$7 million to maintain funding for maternal mortality and morbidity safety initiatives.

TETAF's Legislative Workgroup meetings will continue through the end of the legislative session. The calls are every Friday at 10 a.m. CST. You can [register here](#) to attend the Zoom meetings.


